# Parking Agreement

1. Only an agreement for parking is hereby granted and no liability is assumed or acknowledged.
2. Monthly Parking fees must be paid by the third day of each month. Failure to pay within the first three days of a new month may result in the termination of this agreement.
3. The parking card that is issued is not transferable to any other person or persons.
4. As per safety and fire regulations, propane vehicles and vehicles leaking any fluids are not permitted in the parking garage.
5. Monthly Parking pass holders must not park in fire routes or disability parking spaces (unless in possession of valid permit). Pass holders must only occupy one space at a time. Failure to abide may result in ticketing and / or towing of your vehicle.
6. Monthly Card holders must have their parking card in their possession at all times. Failure to have it will result in normal parking rates having to be paid.
7. A lost or damaged card will be replaced at a charge of \$5.00 per card.
8. Parking Fees will not be refunded if pass is cancelled during payment period.
9. Failure to abide by this agreement will result in the termination of this agreement without refund.
